# Anti-bribery management system as a tool to increase quality in health sector

Period: 01.09.2019 - 15.12.2019

Funding body: Ministry of External Affairs in Romania

Budget: 45,000 EUR

The overall objective of this project was to promote the international standard ISO 37001- Anti bribery management system for the Municipal Clinical Hospital "Sfantul Arhanghel Mihail" in Chisinau in order to contribute to re-establishing the focus on patients, to introducing performance measurements leading to the improvement of the quality of care and to quality system improvements.

#### Results achieved:

- 1 anti-bribery management system at the level of the Municipal Clinical Hospital "Sfantul Arhanghel Mihail" in Chisinau
- 3 training sessions delivered to the medical staff of the of the Municipal Clinical Hospital "Sfantul Arhanghel Mihail" by 2 international anti-corruption experts;
- 1 national conference about the implementation of the international standard ISO 37001- Anti bribery management system at the level of Moldovan medical institutions with the participation of the representatives of the Ministry of Health and directors of 12 rayonal hospitals.
- 8 mass-media appearances at TV and online press.

Period: 01.08.2018 - 31.07.2019




